**Orders for product not currently in stock require a 50% deposit in advance. All orders must be paid-in-full prior to shipping.**

**All communications between your customers and TP Engineering regarding warranty service and technical support will be routed through your company. Customers purchasing complete engines must return completed warranty registration forms to TP Engineering accompanied by a copy of their original invoice complete with serial number and purchase price within 30 days of purchase in order to activate their coverage.**

**All accounts are reviewed annually and those found to be dormant (no purchase within one year) are removed from our system. Once removed, a new dealer application would have to be submitted in order to re-activate an account.**
